JUSTIFICATION FOR NICHOLAS VELTRE

The File Room is a very essential and labor-intense Unit in the Prosecutor's Office. It is where the closed files are stored from year-to-year. From 2007-2010 there are approximately 25,000 to 30,000 files stored in the File Room.

In addition to maintaining the entire filing system, the Clerk is responsible for a myriad of other responsibilities, which includes: archiving; coding; data entry; requesting and receiving files; keeping records of request forms and order forms for/from Cornerstone Archiving Facility for assistant prosecutors, detectives, support personnel and other agencies related to court matters, investigations, trials, etc.; delivering files that are requested to the appropriate person(s); filing of paperwork pertaining to a specific file; maintaining the Papervison and Paperflow Program for requests that pre-date the Promis/Gavel System, (McBee cards); transporting all files to and from court that are scheduled for sentencing, pre-trial conference and arraignment each week, in addition to, files that are requested by the judge at a moments notice; maintaining the bench warrant files that are currently stored in the File Room, and the old bench warrant files that are stored in the old Jail; conducting a monthly inventory of file folders, copy paper, computer paper, green bar paper and subpoenas; delivery of any shipment that is received at the Ruotolo Building; and maintaining and ensuring the hand-trucks that are used for transporting on a daily basis, are in proper working condition.

This position also requires the Clerk to complete and fulfill any other requests from the Prosecutor, First Assistant Prosecutor, Deputy First Assistant Prosecutor, Executive, Senior, Detective, Legal, and Support Staff, including any requests from outside units.

In order to continue to maintain the high standard of work productivity from the File Room, it is **vital** that the vacancy of Clerk, formally held by David Tarullo, be filled as soon as possible. If this vacancy is not filled, the Office will suffer greatly.
